Northern Rivers is a family of human services agencies that work together and are committed to helping children, adults, and families. Formed in 2012, Northern Rivers is the parent organization to Northeast Parent & Child Society (founded in 1888 in Schenectady), Parsons Child & Family Center (founded in 1829 in Albany), and Unlimited Potential (founded in Saratoga Springs in 1979). Together we serve more than 18,000 children, adults, and families in more than 40 counties in New York state who struggle with abuse, neglect, trauma, mental health challenges, educational difficulties, career training and employment, and service navigation through an innovative continuum of home-, clinic-, school-, and community-based services, vocational rehabilitation, supported employment, and senior-supporting programs that provide person-centered, trauma-informed innovative solutions to ensure clients live their best lives. With a 1,400-strong workforce and informed by our nearly 200-year heritage, our quality of care, depth of programs, combined size, and passion for the mission make us a leading human services provider.

Challenges Our Children Face

The children in our care face challenges in four main risk factors: trauma, developmental disabilities, mental health, and juvenile justice. Adverse childhood experiences (ACES) have been shown to increase risks for disease, disability, and early mortality; 97 percent of the children in our care have suffered at least one ACE; 80 percent have experienced four or more.

ACES include sexual abuse, physical abuse, emotional abuse/neglect, medical trauma, domestic violence, parental incarceration, criminal activity in the home, disruption in caregiving, and abuse due to sexual orientation/gender expression.

Many of these issues repeat generation after generation—parents who have experienced ACES in their youth have a much higher tendency to expose their own children to ACES.

In fact, nearly 65 percent of caregivers have experienced at least one of the following traumatic events: sexual abuse, physical abuse, medical trauma, natural disasters, family violence, criminal acts, neglect, or attachment losses. Almost have of caregivers have experienced two or more.

Our challenge is to help those in our care develop resilience by understanding their challenges, creating environments where they feel physically and emotionally safe, and helping them develop supports and connections in the community.





Behavioral Health Services

Unlimited Potential increases the opportunities of individuals with mental illness by providing vocational rehabilitation and employment services.

- One-on-one employment services to determine job preparedness, develop job search strategies, provide on-site job training, support and advocacy
- Support in all aspects of vocational services
- Transition services to support as they move from high school to the world of work and adult life
- Individual testing programs to help find what types of careers work best for each individual while considering personality, capabilities, aptitudes and education
- A social model day program serving eligible individuals age 50 and older to reduce isolation and increase social interaction through a variety of social, physical, and educational activities
- Peer support services emphasize independence and selfreliance and develops the skills needed to function in the community outside of the mental health system
