Another branch of our family tree began in 1888, when the Home for Destitute Children was formed by another group of concerned women in Schenectady. Over the years, these two organizations grew and evolved, with the Orphan Society eventually becoming Parsons Child & Family Center and the Home for Destitute Children becoming Northeast Parent & Child Society. In 1979, Unlimited Potential was formed in Saratoga Springs. In 2012, our Albany and Schenectady branches joined to form Northern Rivers, with Unlimited Potential joining the family in 2019. Today, as one of the leading human services organizations in New York state, our continuum of care serves more than 18,000 children, adults, and families throughout more than 40 counties each year.

## Work-Life Balance

For his final three years of high school, Thomas helped out in our school cafeteria as part of our vocational program. Upon graduation, we just weren't ready to lose his services — so we hired him as a staffer. "The day I got my staff shirt, I realized that this was it, I'm starting a new life," he said.

After a summer of increasing responsibilities, Thomas sent us a note thanking us for the opportunity and saying that he wouldn't be able to stay on, as he was starting his collegiate automotive technology studies. But we weren't ready to lose a valued employee, so we were able to work with him to stay with us as a per diem employee.



SATRI (the Sidney Albert Training and Research Institute) has a tall order, providing training both for our 1,400-strong workforce and for thousands of professionals and organizations statewide. With years of strong growth for our external professional development and training options, this year SATRI bolstered our efforts to retain great staff. They've worked with the entire human resources team to focus on onboarding training for new employees, developing more than 35 new trainings customized to the unique needs of each of our service divisions. # 8.5% COLA for Human Services Retain Staff & Keep the lights on

Northern Rivers isn't the only organization working to help children, adults, and families change their lives. All throughout New York state, nonprofits large and small provide vital programs to people in need. The organizations that make up New York's nonprofit Human Services sector face a host of challenges challenges that can only be overcome if we stand up together to fight for what's right.

The majority of our rates, and by extension our ability to pay workers and run programs, are set by state elected officials. Every year, these leaders make budgetary and policy decisions that dictate what organizations like ours are able to do. That's why it's so important that we make ourselves heard whenever we can.

We've stepped up our advocacy efforts because we believe our clients deserve the opportunity to succeed. Faced with more than a decade of wages that have fallen far behind the pace of inflation, we fight for initiatives like a fair cost of living adjustment (COLA), adequate funding for prevention services, and special education rates that actually cover our costs.

Whether it's empowering employees from our programs to reach out to their local legislators, organizing rallies at the Capitol, supporting call- and write-in campaigns, participating in public events to demonstrate our impact, or meeting directly with state officials, we're fighting on behalf of everyone impacted by these decisions.

This year, we've gone even further. We led an initiative that brought 30 organizations from throughout the state together to speak with one voice directly to the Governor, the State Senate, and the State Assembly, capped by a billboard steps from the Capitol.

In the end, we didn't get everything we asked for, but we did get their attention and their acknowledgment. We're nowhere near finished.

We were honored to be asked to participate in a public event discussing mental health resources led by U.S. Secretary of Health and Human Services Xavier Becerra in January.

# Foster Care Opens New Office

Over the past 12 years that we've served Herkimer, Madison, and Oneida counties, the need for foster parents in this area has continued to grow. That's why we opened a new office in the heart of Herkimer, so our foster care team could be right in the neighborhood to provide support whenever needed. We celebrated the ribbon-cutting in May with leaders from the NYS Office of Children and Family Services and community leaders.

## Youth Art show

Thanks to an incredible donation from Capital District Physicians' Health Plan (CDPHP), we were able to host the first-annual Northern Rivers Youth Art Show! Brilliant, passionate young artists from our residential programs in Albany showed off more than 50 inspiring works to an appreciative crowd of honored guests, staff, and their peers.





## New School Gym Opens

Our school in Schenectady was built in 1951, and in all those years the gym has seen quite a workout! After a yearlong construction project, we cut the ribbon on a beautiful new facility this spring—and welcomed our new school mascot, Navi the Gator.

### Two New Youth ACT Teams Launch

After years of successfully operating an Assertive Community Treatment (ACT) for adults in Saratoga, Warren, and Washington counties, we were selected by the NYS Office of Mental Health to launch two of the first Youth ACT teams in the state—one serving Albany and Schenectady counties, and shortly thereafter a second team serving Saratoga, Warren, and Washington counties. The teams provide intensive, community-based services to youth ages 10-21 who struggle with serious mental illness, enabling them to safely and successfully overcome challenges in school, at work, at home, in social situations, and with physical health and wellness.
